We are the attorneys for the above referenced District and, as such, received and reviewed your written request of August 30, 2016, for production of certain District records pursuant to the Texas Public Information Act, Texas Government Code, Section 552.001 et seq. (the "Act"). The request was received by our office on August 30, 2016. In an effort to timely respond to your request in accordance with the Act, we submit the following on behalf of the District and its designated records management officer.

1. Your letter requests tallies, registered voters list and ballots for the District's Confirmation and Director Election and Bond and Maintenance Tax Election (the "Election"). Accordingly, in response to your request, we have enclosed the Tally List and coordinating Return Sheet as well as the ballots from the Election held on May 7, 2016. With respect to your request for the registered voters list, said list was sent to the voter registrar for Montgomery County pursuant to Texas Election Code § 66.0241 and are no longer in the custody of the District. 3. Your letter requests copies of summaries, reports or invoices relative to the Election. Accordingly, please find enclosed documents in the District's possession responsive to this request.

4. Your letter requests copies of any reimbursement requests or reimbursement payments for the Election costs. Please be advised that no requests for reimbursement of Election costs have been received to date, and, therefore, no reimbursements for Election costs have been made. Accordingly, the District is not in possession of any documents responsive to this request.

5. Your letter requests copies of street verification documents relative to the Election. Accordingly, please be advised that, to date, no roads have been constructed within the District, and, therefore, no street verification documentation is available at this time.



 - date of election
 - precinct number
 - type of election
 - name of presiding judge
 - signature of person keeping the tally sheet
3. Periodically, the tally sheets must be compared for any errors or discrepancies, and if they are found, the ballots, must be recounted and the necessary corrections made.
4. In all elections where straight party voting is allowed, it is necessary to list the name of each political party under the column for candidates. A straight party vote is one in which the party box is marked and other individual boxes for candidates for other parties are marked. Count a straight ticket allot by tallying for the political party receiving the vote instead of tallying for each candidate of that political party to avoid duplication of votes. (See below)
- After all ballots are counted and the election judge is making out the returns, the election judge must add the total number of straight party votes to the total for each candidate of that political party. (Sec. 65.007)**
5. A ballot on which the party box is marked but individual boxes for other candidates are marked is not considered a straight party vote and must be tallied as a split ticket. Tally a vote for each candidate of the political party for which a straight party vote is indicated except for any candidate of that party opposed by a candidate for whom a vote is individually indicated. Tally a vote for each candidate individually indicated.

6. For valid write-in votes for candidates whose names do not appear on the ballot, the name of the write-in candidate shall be entered on the tally list and the votes shall be tallied in the same manner as votes for a candidate whose name appears on the ballot. (Sec. 65.008)
7. When a member of the counting team must be replaced, correct any existing discrepancies in the tally lists. The officer being replaced certifies to the accuracy of that tally list by signing at that time and indicating the final vote tallied by him/her for each candidate or proposition.
8. On completing the count, each counting officer computes the total number of votes cast for each candidate and for or against each proposition and enters the totals on the tally list. After verifying that all three are in agreement, each counting officer signs that officer's list.

TEXAS ELECTION CODE

Art. 3.02(c). In elections where paper ballots are used, the ballots shall be counted by one or more sets of counting officers, each set to consist of one judge or clerk who shall read the ballots, and one or more clerks who shall enter the votes on tally lists prepared for the election. As a safeguard in the accuracy of the tallying, the votes shall be entered on three original tally lists, and during the progress of the counting the lists shall be compared and errors and discrepancies shall be corrected, and at the close of the counting the tally clerks shall certify officially to the correctness of the lists.


